### GENERAL CONDITIONS :

It is forbidden to sublet or assign to a third party . In case of incorrect declaration of the lessee, this contract will be terminated automatically and the sums paid will remain at the campsite. Jurisdiction clause: any disputes will be the exclusive jurisdiction of the court of Mont de Marsan .

**IMPORTANT: In case of cancellation , the sums paid remain acquired at the campsite.**

I subscribe to the cancellation insurance ( 3.5% of the total price of the stay without administrative fees ). See conditions on our website .

In case of breakdown or slight against time and, unless otherwise advised by you, the payment of the deposit ensures the maintenance of the reservation 24 hours after the scheduled date of your arrival. This contract agreement is binding on both parties. The tenant must be insured in civil liability.

**In case of early departure, whatever the reason, the entire booked stay will be at the campsite . Any modification may or may not result in a change in the amount of the stay must be reported on arrival.**

Any reservation request must be accompanied by a deposit, the amount of which is fixed on the reservation voucher.

### SPECIAL CLAUSES ACCOMMODATION RENTALS:

**For rentals of mobile homes and chalets, two deposits are required at the entrance to cover any losses and cleaning costs: 400 euros + 60 euros cleaning for 2/4 people/ 600 euros + 80 euros cleaning for rentals 6 people .**

**The deposits will be returned to you within 10 days of your departure, if problems, they will be cashed.** These sureties do not constitute a limit of liability. **The mobile homes and chalets must be left clean** (a vacuum cleaner is available at the reception).

The rental of the mobile home or chalet is granted only by a period of one full week (Saturday or Sunday 17H to Saturday or Sunday between 8:30 and 10 H at the latest). In case of disagreement on the inventory available in the rental, it is imperative to report the day after your arrival.

### INTERNAL REGULATIONS:

**The tenant acknowledges having received a copy of the rules and undertakes to respect it.** I acknowledge having read and unreservedly accept the conditions of reservation and rental. For this rental to be definitive, it must be accompanied by a deposit.
